Mesa Winds Farm 2011 Fruit CSA

What is a CSA?

“In basic terms, CSA consists of a community of individuals who pledge support to a farm operation so that the farmland becomes, either legally or spiritually, the community’s farm, with the growers and consumers providing mutual support and sharing the risks and benefits of food production.”

Membership in Mesa Winds Farm CSA entitles you to a share of our certified organic peaches, apples, and table grapes for 2011 plus a bonus jar of our Mesa Winds Farm Honey. Each week you will receive a bag of approximately 4–8 lbs of fruit that we harvested that week. We aim for you to receive about 60 lbs of fruit over the course of mid-August to October.

How does it work?

You can purchase a fruit share membership from Mesa Winds Farm. You will then pick up your weekly fruit share at CFAM (Colorado Farm and Art Market) at our booth. You’ll be notified when deliveries start and we’ll continue weekly thereafter.

How much does it cost?

The cost of a share is \$150, payable in advance. We will apply your share monies towards our crop expenses and you’ll have delicious fresh Certified Organic western slope fruit delivered to the Springs for 8-9 weeks during the peak of Colorado harvests!

Our farm values and needs Eaters! Our goal is to provide the most delicious and nutritious fruit and make it available at a fair price. Our entire farm is USDA Certified Organic by Stellar. Our farm has been certified organic for over a decade, and we are transitioning to certified biodynamic. Biodynamic standards are based not only on use of organic pesticides, herbicides and fertilizers, but upon sustainability and ecological farming practices.

I understand and agree that my share payment does not guarantee me an exact amount of fruit. I am making a commitment to support regional farmers and to share in the rewards and the risks of the growing season. I also understand that my payments are nonrefundable after June 1 and danger of frost is past. It is my responsibility to pick up my share during farmers markets ([CFAM](#)) Mesa Winds Farm attends or a mutually agreed upon location TBD. I understand that if I am out of town or otherwise unable to pick-up my share at any time during the season, I am responsible for contacting a friend or neighbor to gather my produce or donate it to a local food bank.

Deliveries will begin when Mesa Winds Farm (MWF) begins to harvest fruit, most likely mid-August, 2011. Shareholders will be notified in advance of the first pick-up date and location. Deliveries will be weekly thereafter for 8-9 weeks. The final pick up will be announced in advance. MWF hopes, but cannot guarantee, to deliver approximately 60 lbs of fruit.
